**RLC TO BUILD FIRST MIXED-USE PROJECT IN EASTERN VISAYAS.
PROJECT TO INCLUDE SHOPPING MALL & CALL CENTER IN A 4
HECTARE PROPERTY**

Robinsons Land Corporation (RLC) recently unveiled its latest provincial mall project in Tacloban City, Robinsons Tacloban, which is expected to break ground by the 1st quarter of 2008 and with a scheduled opening by end of 2008.
